INSTRUCTIONS

- 1. The request for correction of transcribing error in Name/Father's Name/Gender/Picture of a candidate may be considered on submission of an application on the prescribed Proforma duly recommended by the Head of concerned Institution/Principal, in case of regular candidate(s) and from Class-I Gazetted Officer (Lect. Headmaster BPS-17 and above education officer) in case of **Private candidate and those candidates who shifted to Pakistan from Institutions Abroad**, along with prescribed fee and provision of following documents to the satisfaction of the Board:
 - a. Attested copy of SSC Result Card/Certificate, Correction letter issued by the FBISE, in case the candidate passed his/her Examination from any other Board, Original verified copy of the SSC/HSSC-I Result Card/Certificate, from concerned Board/Equivalence Certificate from IBCC must be provided.
 - b. Attested copy of HSSC Registration Card/Result Card/Certificate duly attested by concerned Head of Institution/Principal
 - c. New Picture and Form "B"/SSC Result Card (in case of correction of Picture/Gender)
- 2. Board mistake shall be corrected without fee within one year of the issuance of Registration Card/Result Card/Certificate, where after, fee shall be charged as per schedule.
- 3. Special children (**physically handicapped, deaf and dumb, blind etc.**) are exempted from all sorts of fee payable to the Board. Please attach the Medical relevant Certificate issuance by the Govt. Hospital, alongwith Correction case.
- 4. Case Processing Fee as per schedule given below which is subject to revision from time to will be charged at HSSC level:
 - i. Rs.2500/-(Inland)/US \$ 55/- (Abroad) within three (03) years of passing HSSC examination.
 - ii. Rs. 5500/-(Inland)/US \$ 160/- (Abroad) after three (03) years of passing HSSC examination.
 - iii. Request for Correction after six years of passing HSSC examination will be entertained on additional Payment of Rs.500/- Inland)/US \$ 10 (Abroad) per annum over and above the aforementioned prescribed fee as at para 4 (ii).

Note:

- 1. Any request for correction found incomplete in any respect shall not be entertained.
- 2. Complete case for any correction must be submitted within three months after fee is remitted. Thereafter fresh fee will be charged.
- 3. Fee once deposited will not be refunded being case processing fee.
